Voter Disenfranchisement *IS* the Republican Playbook

Their Plan to Keep a Majority in Congress

In several states with extensive documented histories of discriminating against Black voters, Republicans have updated their disenfranchisement techniques to sheer defiance of federal court decisions. In Alabama, Louisiana, and Georgia – all of which have well-known histories of deterring Black voters by instituting poll taxes, literacy tests, voter challenges and violence – the 2023 playbook is redistricting to dilute Black voting power: redrawing congressional district lines to eliminate Black-majority congressional seat districts by stuffing Black voters into majority-white districts, otherwise known as "cracking and packing."

Thus, when Alabama Republicans were handed a surprising defeat last year by the Supreme Court striking down their "cracked & packed" redistricting maps that eliminated a congressional seat in a transparent effort to keep Black voters from electing a candidate of their choice, they were undeterred. In a shocking act of defiance, the Republicancontrolled Alabama legislature simply ignored the US Supreme Court and drew another set of similar maps to deny a seat to Black voters.

When these new maps were challenged, the Alabama Republicans *conceded* the purpose behind them but still argued to a three-judge panel of the federal Eleventh Circuit Court of Appeals that the unfair gerrymandered maps should stay in place for the 2024 elections. Fortunately, the panel (two Trump appointees and one Reagan appointee) lambasted the legislature's brazen defiance.

The Republican legislature in neighboring Louisiana also eliminated a seat that likely would have gone to a Black representative. Louisiana keeps fighting to keep the unconstitutional maps in place, in similar defiance of the high Court.

Similarly, in Georgia, the Republican-controlled legislature drew maps in 2021 to dilute the voting power of the Black electorate. A Georgia state court allowed those maps to remain in place for the 2022 September 2023

election; however, a challenge to them is set to go to trial.

Finally, not to be outdone, the Republicancontrolled Wisconsin legislature is threatening to impeach the newest member of that state's Supreme Court – before she even decides a single case – to prevent the formation of a majority on the court to throw out the legislature's gerrymandered maps.

Blatant disregard of voters, their choices, laws, and even US Supreme Court orders *is* the Republican brand. It is anti-democratic and dishonest, but unsurprising coming from those who admire an ex-president who has a particular disdain for truth and disregard for voter enfranchisement. It is up to us to keep up this fight and win back Congress. And we will need to be vigilant and have all hands on deck for that fight.

It looks like there are two fairly minor ballot proposals; we'll get you info on those next month. Between the 2020 and 2022 general elections, states reported removing over 19 million voters from their registration rolls. Many of these removals were for routine reasons, but some eligible voters were wrongly purged based on flawed grounds like "inactivity" that disproportionately target Black and Brown voters.

Think-tank Dēmos <u>recently released a report</u> evaluating voter removal practices in ten different states. It analyzes purge practices, the safeguards in place to protect voters from disenfranchisement, and accessibility and transparency of voter data.
